Description:

Hand Cleaning Creme Extreme is a powerful creamy, alkali-,solvent- and silicon free hand cleaner which is specially developed for removing effective removal of especially stubborn soils such as oil-based paints, lacquers, resins and adhesives. *Hand Cleaning Creme Extreme* is a beige like, slightly perfumed suspension containing ester-based solvent and a natural oil for outstanding cleansing action combined with proven skin compatibility. This addition of esters in combination with the natural oil makes the hand cleaner more skin friendly than a hand cleaner which is based on common hydrocarbon solvents. The product does not contain environmentally damaging micro plastic scrubs and is relatively low odour perfumed for a wide customer acceptance. The scrubs in the product are rounded non irritating plant based scrubs. The product does not clog the drains. The product is dermatologically tested. The product complies with the European Cosmetic Regulation 1223-2009.

Application:

Hand Cleaning Creme Extreme for intensive hand and skin cleaning after extremely soiling work. Specially developed for removing paint, oil based paint, acrylic paints, varnish (e.g. two-component varnishes), special adhesives, PU adhesive, resin, printing ink, fats, oils, additives, lubricants, lacquer etc. Due to the addition of the natural oil, also oils and grease is easy to remove from the skin. The hand cleaner is ideal for use in body repair shops, garages, paint workshops and printing industries.

Method to use:

Hand Cleaning Creme Extreme is used on slightly wetted hands or directly on even dry hands. Rub a small quantity into hands, add some water when needed and wash your hands until all the dirt has loosened from the skin. After rubbing in the hand cleaner, rinse thoroughly with water and dry the hands gently.

By handling chemicals and other damaging pollutions which form a risk to the skin a barrier cream before work is advised. After working with skin damaging pollutions the hands have to be cleaned thoroughly first and then a gently hand cream has to be used.
